Mark Powers motioned to put "AN ORDINANCE APPROVING CHANGE ORDER NO. 1 TO AN AGREEMENT BETWEEN THE CITY OF CARL JUNCTION, MISSOURI AND G&G CONSTRUCTION COMPANY, INC., TO CONSTRUCT THE WASTEWATER TREATMENT PLANT EXPANSION FOR THE CITY OF CARL JUNCTION, MISSOURI, SAID CHANGE ORDER NO. 1 BEING TO INSTALL A 480 VOLT BREAKER, RELOCATE THE ANNUNCIATOR PANEL FOR THE STANDBY GENERATOR, REMOVE AND REPLACE 200 FEET OF FENCING AND TO EXTEND THE CONTRACT COMPLETION DATE BY 120 DAYS, FOR AN ADDITIONAL COST OF \$7,023.00, AND INCREASING THE TOTAL CONTRACT COST TO \$2,939,023.00; AND AUTHORIZING THE MAYOR TO EXECUTE SAID CHANGE ORDER NO. 1 FOR AND ON BEHALF OF THE CITY OF CARL JUNCTION, MISSOURI" on first reading by title only. Richard Zaccardelli seconded. Steve said that the fence is along the East side but they are talking about upgrading the fence along Joplin Street also. There was discussion as to why this was not in the original bid and why Allgeier-Martin did not catch it. DNR has already approved this. Mark Powers motioned to put it on second reading by title only. Don Marshall seconded. There was no discussion. Mark Powers motioned to put it on final passage. Richard Zaccardelli seconded. All in favor. No opposed. Cook-y, Marshall-y, Zaccardelli-y, Powers-y, T Smith-y, Spencer-y, W Smith-y, Allen-y. Motion on Ordinance #15-24 was approved by roll call vote, signed by the Mayor, attested by the City Clerk and made a part of the permanent records of the City of Carl Junction.

Public Works report - had nothing to add to report. Richard thanked Jimmy for spraying. Bob Cook said that there is a pothole at the Post office and that there is some storm water needing addressed by the Hances on Valleyview. Steve said that he and

Jimmy have looked at that and there is not much we can do. Steve doesn't think it is our problem but he will contact him. Tim Smith said that there are lily pads on Lakeside Park pond. Tim asked if Southard indicated when they were going to start.
